FORIG PROJECTS

QUALITY CONTROL AND STANDARDIZA-TION OF GHANAIAN WOOD PRODUCTS

The world market for furniture in the year 2000 was estimated at US\$38 billion of which the share of wooden furniture was about US\$12 billion. Philippines for example earned US\$ 500 million from export of wood furniture and it is the 5th foreign exchange earner. Ghana with similar resource capacity has prospects to capture a good share of the world's furniture market.

On the contrary however, Ghana is a 'leading' importer of cheap furniture mainly upholstery, chairs, door and other wooden products from the East mainly because of their design and finishing. Ghana cannot boast of furniture export but timber and some few tertiary timber products.

Even though the quality of timber from Ghana is widely acclaimed on the world market, the same cannot be said of the wood products meant for the local market. There were also no quality control guidelines for furniture and some other wood based products. Furthermore, the local market needs were completely "ignored" in the formulation and implementation of most of the quality control guidelines and grading rules.

The Call for Standards

With this background, Dr. V.K. Agyeman of CSIR-FORIG in 2004, organised a team of scientists to investigate the quality of wood products on the local market and the consumer's perceptions. The results indicated that furniture manufactured in Ghana did not meet any standards, be it physical or structural. Using British Standard:

BS 4875 part 1, 2001, furniture examined would not pass moisture content, drop, seat, back and arm static tests among others. The consumers at all levels sampled were also ignorant of wood standards and choice. It was also observed that the universities, research institutions and other wood training centres lack wood standards.

These findings were supported by the recommendations of a national workshop on "standardization of wood products for furniture, building and construction" held for stakeholders in 1997. The workshop identified that the timber industry displayed little or no experience in managing the production and quality control of their production process .

Other studies that influenced the preparation of this project were results of the Wood Industries Development Project (WIDP) of the Natural Resources Management Programme, which was undertaken between 1999 and 2003. Furthermore, the "Wood industry and log export ban study (WILEBS) of May 2002 established that Ghana's forest industry will only be sustainable if it addresses issues of good governance, economic distortions, accommodation of community interests and ensures sustainable quality control and standardization of products.

A three-year project was therefore conceived to develop and promote the application of quality control guidelines and standards for Ghanaian timber and wood products. The project led by Dr. V. K. Agyeman employed Mr. George Ametsitsi to coordinate the day-to-day activities of the project. The project has so far produced five wood products standards for the local markets.

Tangible Outputs of the Project

Ghana Standards on timber products produced by the ITTO Quality Control and standards project are:

- GS 980: 2008 Furniture—Specification for Tables
- GS 981: 2008 Furniture—Specification for Seating
- GS 982: 2008 Furniture—Specification for Bedsteads
- GS 983: 2008 Furniture—Specification for Furniture Components
- GS 984: 2008 Semi-Manufactures of Timber— Specification for Planned Timber and Mouldings

Ghana now has 15 wood product standards, of which five or 33% are products of the project. In addition, they represent 71% of standards available for carpenters and joiners. The major tangible output of the project was the implementation of timber and timber products standards which also contain quality control procedures and glossary of terminologies to guide the average artisan or buyer.

Another major achievement of the project is the training



of two scientists in quality control of timber products, general application of wood, furniture manufacturing technology and furniture testing among others.

Furniture Testing Machine

Beneficiaries of the training are now capable of applying British and American Standards to wood products finishing, quality evaluation and machine testing of physical properties of furniture.
